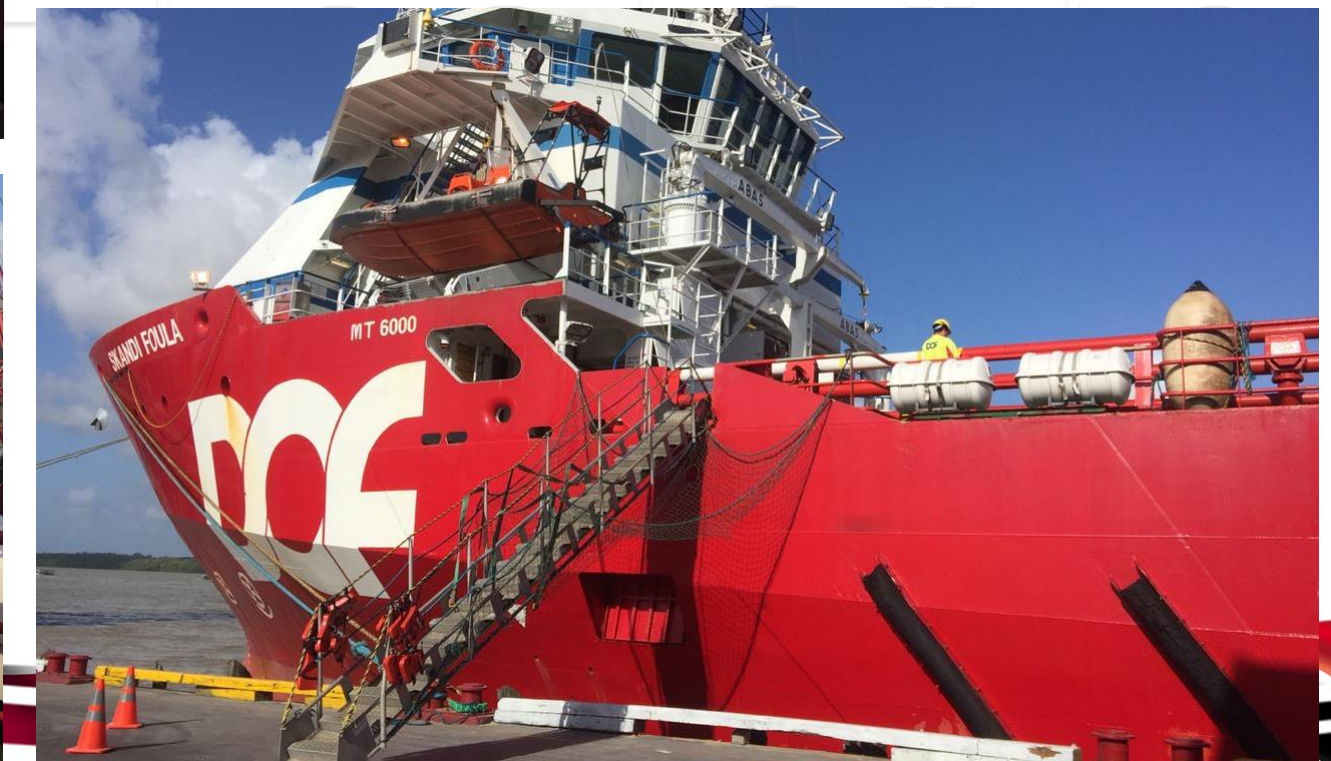
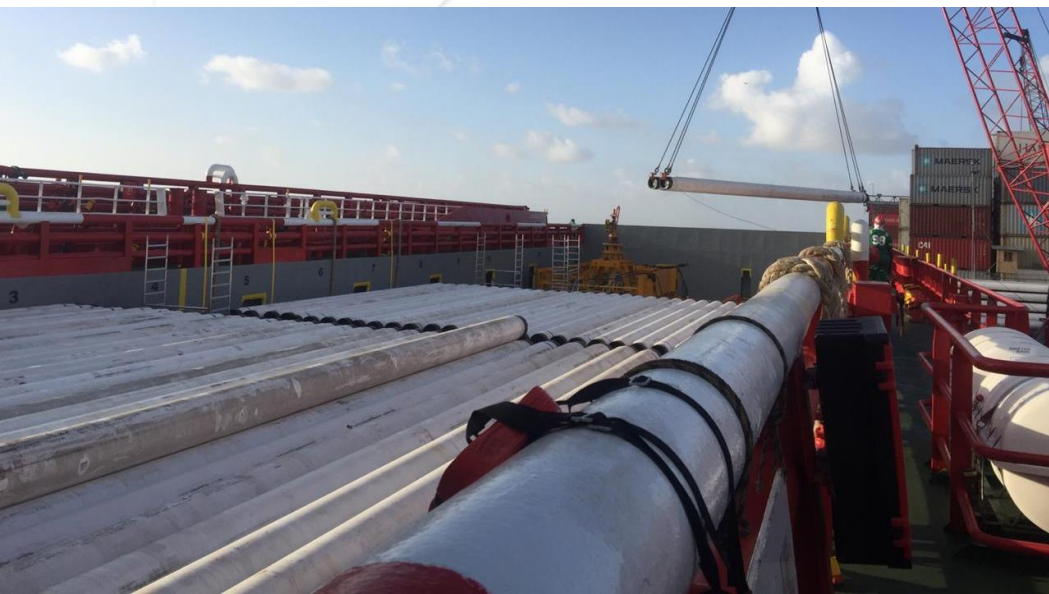
# SAIPEM Guyana PROJECT

Ramps Logistics had the opportunity to load 505 massive pipes onto 3 supply vessels - the M/V Skandi Foula, M/V Skandi Buchan and the M/V Enterprise.

The scope for work included:

- Loading of pipes onto 3 vessels
- Customs clearance for the SAIPEM FDS-2

These pipes will be laid on the seafloor at the Liza Phase One Development, located offshore Guyana at a water depth of 1,800 meters.

## FDS-2 Vessel Clearance - Guyana

Our Guyana team worked alongside the Customs and Immigration unit and in collaboration with our partner John Fernandes Limited to clear Saipem's FDS-2 vessel. This will be the primary pipe-laying vessel to connect the subsea structures to the FPSO where the oil will flow!

We are grateful to be a part of the historic feats that progress offshore Guyana. It is an incredible feeling to be part of the building process that paves the way for greater things on the horizon!



## Kosmos Energy - Suriname
